Intro/Acceptance

The following terms and conditions (the “Terms of Use” or “Terms”) are the Terms of Use for our website: www.goparity.ca (the “Site”) made available by GoParity Canada Inc.

The contents of the Site include, without limitation, all information, data, products, materials, services, software applications and tools, design elements, text, images, photographs, illustrations, audio and video contents, artwork, graphics contained therein or otherwise made available to you in connection therewith (collectively the “Contents”) and, unless the context clearly requires otherwise, or we explicitly say so in writing, the term “Site” includes all of the Contents.

These Terms of Use and the Privacy Policy constitute a legally binding agreement between you and GoParity Canada Inc., its subsidiaries and affiliated companies, including, without limitation, GoParity Canada Funding Inc. and GoParity Canada Securities Inc. (collectively, the “GoParity Entities” or the “Company”), regarding your use of and access to the Site. You acknowledge and agree that the GoParity Entities may, in its sole discretion, change, improve and/or correct any functionality or Contents of the Site and suspend and/or deny access to the Site for any reason, without any obligation and without any notice.
